

TERMS AND CONDITIONS

All prices, packages, programming and offers subject to change without notice. Offers valid from 2/01/12 through 5/20/12.

PROGRAMMING CREDITS Requires 24-month Agreement. With qualifying programming you will receive a credit for each of the first 12 months after service activation, as follows: \$20 per month with America's Top 250, America's "Everything" Pak; \$15 per month with America's Top 200; \$13 per month with DishLATINO Max; \$10 per month with DishLATINO Dos, DishLATINO Plus; \$5 per month with America's Top 120, America's Top 120 Plus, DishLATINO Clásico, DishFAMILY.
